The project organized by Diplomatici and ASviS, *"Exploring the United Nations Economic and Social Council's Role in the promotion of the Agenda 2030 for Sustainable Development"*- *Empowering people and ensuring inclusiveness*- aims at providing students and young professionals with the chance to experience a high-level training course on international cooperation and sustainable development.
